PORT ST. LUCIE'S EXPERT SHUTTER SERVICES RECOGNIZED AS A 2018 FLORIDA COMPANIES TO WATCH

Port St. Lucie — The Economic Development Council of St. Lucie County, the City of Port St. Lucie and GrowFL are pleased to announce that Expert Shutter Services is among 50 statewide honorees selected for the 2018 Florida Companies to WatchSM. These companies were selected from more than 500 nominees for the award, hosted by GrowFL, a statewide economic development organization, in association with the Edward Lowe Foundation.

Expert Shutter Services' management team, competitive market position and strong community involvement were among several factors that put them in contention for the award. "These standout companies are all led by entrepreneurs, and have demonstrated their capacity and intent to grow," said Dr. Tom O'Neal, GrowFL executive director. "They also all have critical intellectual property or a niche position that gives them a competitive edge in their markets," he said.

Second-stage companies are defined as those with 6 to 150 full-time employees and between \$750,000 and \$100 million in annual revenue. There are many programs and incubators promoting start-up businesses; GrowFL is the only Florida program that focuses exclusively on second-stage companies.

"We couldn't be prouder of Mike Heissenberg and the Expert Shutter Team, said Mayor Gregory J. Oravec. They are part of the Great American Success Story, transforming hard work and ingenuity into a garage-based start-up and then an award-winning profitable second stage company. We look forward to their continuing success and growth."

The 50 companies named the 2018 Florida Companies to Watch generated nearly \$1 billion in revenue and added nearly 1,000 jobs between 2014 and 2017. Together, the companies project a 50 percent increase in revenue and 40 percent increase in job growth in 2018 compared to 2017.

Expert Shutter Services will be officially recognized February 9, 2019 at the Straz Performing Arts Center in Tampa, FL with the statewide honorees at the 2018 Florida Companies to Watch event.
