## Recruitment/ Expansion UPDATES



### **CITY ELECTRIC SUPPLY/TAMCO**

Construction is expected to be complete on the 411,000-sq.ft. facility in the third quarter of 2019. This project, the first new industrial business in the Tradition Center for Commerce, retained 210 jobs and will add 50 new jobs.



## **OCULUS Surgical**

This existing St. Lucie West business will be expanding into a new 50,000-sq.ft. state-of-the-art facility in the Tradition Center for Commerce, retaining 32 employees and adding 50 new jobs. Construction is expected to begin late 2019/early 2020.



#### **Pursuit Boats**

The site plan has been approved for over 500,000 sq.ft. of new facility space in Fort Pierce. Recently acquired by Malibu Boats, Pursuit currently has 400 employees on their 220,000-sq.ft. site. The first phase, an additional 181,000 sq.ft. of production space, will add 200 new jobs. Construction on the first phase is slated for 3rd quarter.



#### **Concrete Impressions**

Site improvements are underway for this premier manufacturer of sound walls and barriers. The company, currently based in Pompano Beach, acquired 18 acres of land in Fort Pierce for manufacturing and distribution. Once the site is complete, 15 new jobs will be added.





#### A & G Concrete Pools

Construction is complete on A&G Concrete Pool's headquarters. Their new 19,000-sq.ft. facility helped retain over 65 jobs.



#### **Drexel Metals**

This manufacturer and fabricator of metal roof systems has relocated from Martin County into a 25,000-sq.ft. facility in St. Lucie West. Renovations are almost complete and 15 new jobs will be added.



#### **American Concrete Industries**

Following a 10,000-sq.ft. expansion in 2018, ACI is expanding again with 15,000 sq.ft. in Fort Pierce, retaining 24 jobs and creating 15 new jobs. Construction will begin in late 2019.



#### **Convey Health Solutions**

Expanding into a 60,000-sq.ft. Class A office space at the former Liberty Medical Building in Port St. Lucie, Convey will be creating more than 100 new jobs. St. Lucie County Transit worked with Convey to relocate a bus stop, ensuring their existing and new employees will have access to public transportation.



#### **PowerLift Hydraulic Doors**

This existing Fort Pierce manufacturer acquired a 22,000-sq.ft. facility and is currently planning for minor site plan renovations to meet production needs.

Construction is underway on the new MRO hangar at the Treasure Coast International Airport. Standing 57 feet tall with a 43-by-130-foot door, the new MRO hangar will comfortably accommodate two large aircraft.....Aviator College of Aeronautical Science and Technology is expanding its airport-based campus to produce more maintenance technicians while Indian River State College launched a new Aviation and Marine Training program.....Megayachts are coming to the Port of Fort Pierce! The county signed a contract in April with Derecktor Boatyards to refit power and sailing mega-yachts. Local group Fort Pierce Yacht & Ship is already at work on refits at the port.
